We refer to above mentioned letters under reference (1) & (3), vide which you have requested us to incorporate your name in the list of approved vendors for supply of **G.I. Perforated Cable Trays** for use in the various projects of MSETCL.

In this regard, it is to inform that your request is accepted and approved by MSETCL for the supply of **G.I. Perforated Cable Trays** for use in the switchyard works of MSETCL's 400kV, 220kV and 132kV Substations against EPC Contracts, Turnkey Projects, DTF Works & Wind Generation/Co-generation Projects, etc. subject to the followings conditions:

1) **The Registration is valid upto three (3) years from the date of issue of the acceptance/registration letter.**

Validity upto: March, 2022 i.e. 25.03.2022

2) **The registration shall be applicable to Maharashtra State Electricity Transmission Co. Ltd. (MSETCL) for their work of MSETCL's 400kV, 220kV and 132kV Substations against EPC Contracts, Turnkey Projects, DTF Works & Wind Generation/Co-generation Projects, etc. only. This registration approval does not automatically entitle you for getting qualified against the tender floated by**

our Central Purchase Agency (CPA) where stipulated Qualifying Requirement (Q.R.) shall be met by you.


- 3) All the raw materials used in the manufacture of G.I. Perforated Cable Trays shall be of prime grade. Record for the same shall be produced at the time of inspection and G.I. Perforated Cable Trays shall be manufactured as per best industry standards. The above material shall be supplied conforming to MSETCL's technical specifications and all other applicable latest relevant IS / IEC standards.*
- 4) You shall submit Manufacturing Quality Plan for our approval before commencement of manufacturing against any order.*
- 5) Vendor has to maintain high standards of integrity and performance in respect of their supplies and generally endeavor to give no cause for complaints. The quality of material shall not be compromised at any point of time on any grounds what so ever.*
- 6) MSETCL reserves the right to carry out the complete type/routine tests on any of the randomly selected sample of G.I. Perforated Cable Trays without any extra cost implication to MSETCL. The tests will be carried out at any time during the period of validity of vendor registration.*
- 7) You shall always maintain the delivery schedule to avoid time over run of projects.*
- 8) This vendor approval is for the works address mentioned in this letter and will not apply to any of your branches/offices.*
- 9) You are advised to inform us promptly, with necessary supporting documents for any changes in name or ownership or control of the company or address of office, factory partnership deed or any articles of association or your concern telephone number, email address, etc. since your registration, within 30 days of such change and get approval for the same from this office.*
- 10) You are requested to apply for renewal, at least two months prior to the date of expiry of this approval (which is three years from the date of issuance of this letter). If you apply after the due date of renewal your application will be treated as a fresh application for vendor registration and not as a renewal application.*
- 11) If, at any point of time, any abnormality is noticed in regard to any of the above points or performance is found unsatisfactory by any of the MSETCL's office, we reserve the right to withdraw this approval with immediate effect.*

- 12) *It may please be noted that the responsibility of authenticity of all the relevant photocopies of documents submitted by you for vendor approval will rest on you. You shall be solely responsible for any dispute/legal issues arising regarding the submitted documents in future. In such case of any dispute this approval will automatically stand cancelled with immediate effect.*
