1.We refer to above mentioned letter under reference (2) vide which you have requested this office for renewal of vendor approval of your firm for supply of **G. I. Perforated Cable Trays along with Associated Hardwares** for use in the various projects of MSETCL.

2.Based on documents submitted, it is to convey our acceptance for your request for <u>renewal</u> <u>of vendor approval</u> for the supply of **G. I. Perforated Cable Trays along with Associated** Hardwares for use in the switchyard of MSETCL Substations against EPC / Turnkey Projects, ORC / DTF Works and Solar / Wind / IPP / Co-generation Projects for the period of **03(Three)** years from the date of issue of this letter.

3.This vendor approval is only for the works address as mentioned below in this letter and will not apply to any of your branches / offices.

This acceptance is subject to the following conditions:

4.All the raw materials used in the manufacturing of G. I. Perforated Cable Trays along with Associated Hardwares shall be of prime grade and shall be manufactured as per best industry standards. Record for the same shall be produced at the time of inspection of said material.

5. You shall submit the Drawings, Guaranteed Technical Particulars and Manufacturing Quality Plan (MQP) of G. I. Perforated Cable Trays along with Associated Hardwares to this office for approval before commencement of supply to MSETCL.

6. You have to maintain high standards of integrity and performance in respect of their supplies and generally endeavor to give no cause for complaints. The quality of material shall not be compromised at any point of time on any grounds what so ever.

7. You shall always maintain the delivery schedule to avoid time over run of projects.

8.Supply of spares / replacement and after sales service, will be valid for at least period of next Ten (10) years from the date of commissioning or Twelve (12) years from the date of supply of equipment / materials whichever is earlier.

9. This renewal of vendor approval does not automatically entitle you for getting qualified against the tender floated by our Central Purchase Agency (CPA) Department where stipulated Qualifying Requirement (QR) shall be met by you.

10.You are advised to inform us promptly, with necessary supporting documents for any changes in name or ownership or partnership deed or control of the company or address of office / factory or any articles of association or your concern telephone number or e-mail address, etc. within Thirty (30) days of such change and get approval for the same from this office.

11.You are requested to apply for subsequent renewal, at least Two (02) months prior to the date of expiry of this approval [which is Three (03) years from the date of issuance of this letter]. If you apply after the due date of renewal your application will be treated as a fresh application for vendor approval and not as a renewal application.

12.The MSETCL reserves the right to withdraw the vendor approval in case any violation in the design / specification etc., at any given point of time, is brought to the notice.

13. If, at any point of time, any abnormality is noticed in regard to any of the above points or performance is found unsatisfactory by any of the office of MSETCL, we reserve the right to withdraw this approval with immediate effect.

14.It may please be noted that the responsibility of authenticity of all the relevant photocopies of documents submitted by you for renewal of vendor approval will rest on you. You shall be solely responsible for any dispute / legal issues arising regarding the submitted documents in future. In such case of any dispute, this approval will automatically stand cancelled with immediate effect.

15.You are requested to acknowledge the receipt of this letter.
